- Successfully negotiated \$4.7 million settlement for partial taking and damaging of multiple-tenant office complex in DeKalb County, representing a 500 percent increase above the original offer.
- Settled condemnation case involving a partial taking and damaging of a hotel in Rockdale County for nearly three times the original offer.

- Negotiated a settlement for land value of more than double the original offer in the partial taking of land from a retail shopping center for a county water tower project.
- Obtained \$11 million jury verdict in favor of client for the taking of a hotel site by GDOT in Atlanta, representing a 150 percent increase above the original offer.
